



## Education For Less, Inc. Non-Traditional Online Student Scholarship

The Education For Less, Inc. Non-Traditional Online Student Scholarship Program supports adult learners who are committed to earning a degree online. As part of this program, Education For Less provides students up to a 10% tuition scholarship according to the terms herein.

This Non-traditional Scholarship Program Enrollment Agreement (“**Agreement**”) is effective as of the Effective Date set forth below and is between Education For Less, Inc (“**Education For Less**”) and the individual identified below (“**Student**”). In consideration of the mutual promises and obligations contained herein, the sufficiency of which is acknowledged and agreed upon by the parties, the parties agree to the following:

1. **Non-Traditional Online Student Scholarship Program.** We offer a unique scholarship program designed to encourage adult students to earn online higher education degrees in a timely and uninterrupted manner (“**Scholarship Program**”). We want to help you go back to school, earn your degree and save money!
  - a. What is it? A scholarship for non-traditional adult students equaling up to 10% of the cost of tuition.
  - b. Who is eligible? To participate in our scholarship program, you must meet all of the following criteria:
    - i. Be 18 years old or older at the time of scholarship application.
    - ii. Be eligible to receive Federal Student Aid (even if you do not use Federal Student Aid to fund your education).
    - iii. Apply for your scholarship through the website and via our online application form and complete the written agreement.
    - iv. Be accepted and enroll in an online degree program, remain enrolled consistently with no breaks, and complete one or more courses each consecutive term.
    - v. Remain actively enrolled in courses, without lapse. Any break in enrollment (including summer sessions) will result in scholarship disqualification.

- vi. You must provide Education For Less, Inc with permission to access your records from your school to verify your enrollment, attendance, tuition payments and successful degree completion.
  - vii. You must agree to the scholarship program Terms of Use and comply with all of the Terms of Use provisions, as well as all applicable laws.
- c. How much is the scholarship amount? The scholarship program provides up to a 10% tuition scholarship at each registration period.
- d. What if I change schools or degree programs? If you change your degree program or your school after entering into this Agreement, you may lose eligibility and/or your potential scholarship amount may change. Please contact us immediately if your degree program changes so that we can let you know whether your potential scholarship amount will be increased, decreased, unaltered or voided.
- e. Can I lose eligibility? Yes. If you take a break or take any time off from your course load, you will lose eligibility for the scholarship program. You will also lose eligibility if you enroll in classes but drop them or fail to complete them. Additionally, you will lose eligibility if you fail to meet any of the eligibility requirements or breach any of the representations or warranties in this Section 5 or any other terms of the Scholarship Program Enrollment Agreement. Unfortunately, no exceptions will be made.
- f. Are there other limitations? Yes, your right to any scholarship payment will not be earned unless you satisfy each of the requirements listed above. This offer applies only to the online degree programs applied for in accordance with these Terms and any other agreements between you and Education For Less.
- g. How do I receive my payment? Payment is made by Education For Less directly to the school for a credit applied to your student account. It is your responsibility to ensure that your information is accurate.
2. **Changes to Scholarship Program.** Education For Less reserves the right to alter, amend or discontinue the Scholarship Program in its sole discretion, if Education For Less reasonably determines that it cannot continue providing the Scholarship Program, it learns any portion of the Scholarship Program is void or unlawful, or any other circumstances or situation prevent Education



For Less from reasonably continuing the Scholarship Program. If Education For Less make any material changes to the Scholarship Program or discontinues the Scholarship Program, Education For Less will provide you with notice of the changes or discontinuation.

**3. Your Representations and Warranties.** By enrolling into the Scholarship Program, you represent and warrant that:

- a. You're at least 18 years of age.
- b. You meet all eligibility requirements set forth above and will provide documentation or other substantiation of the same upon request by Education For Less.
- c. You will enter into any necessary consent agreements so that Education For Less can verify your eligibility for and successful implementation of the Scholarship Program.
- d. You will notify Education For Less if you discontinue participation in or lose eligibility for the Scholarship Program.
- e. You agree not to create false accounts or to provide false information. You represent and warrant that all information you provide is truthful, complete and accurate. If you violate any of the above representations and warranties, your eligibility in the program will become void and you will not be eligible for any scholarship awards.

UNAUTHORIZED ACCESS TO OR USE OF YOUR INFORMATION; (C) ANY TECHNICAL FAILURES OR ERRORS; OR (D) LOSS, USE OR MISUSE OF YOUR DATA.

EDUCATION FOR LESS PROVIDES NO REPRESENTATIONS AND WARRANTIES THAT ARE NOT SPECIFICALLY SET OUT IN THESE TERMS OR OTHER WRITTEN AGREEMENT WITH YOU. ANY ACTIONS, INACTION OR INFORMATION PROVIDED BY ANY OTHER USER OR THIRD PARTY IS ATTRIBUTABLE ONLY TO THAT USER AND/OR THIRD- PARTY AND NOT TO EDUCATION FOR LESS. IF YOU LIVE IN A STATE THAT DOES NOT ALLOW THE WAIVER OF CERTAIN WARRANTIES, OR LIMITATIONS OR DAMAGES WAIVERS DESCRIBED IN THIS SECTION, SOME OF THESE PROVISIONS MAY NOT APPLY TO YOU. 5. **Indemnification.** You agree to indemnify, defend and hold harmless Education For Less and its affiliates, employees, agents, representatives and third-party service providers, for any and all claims, demands, actions, liability, fines, penalties and expenses, whether based on warranty, contract, negligence, strict liability or otherwise, that may arise from any of your acts through the use of the Scholarship Program. Such acts may include but are not limited to: your submission of information, fraud, unauthorized use of material obtained through the Application, or breach the terms of this Agreement, the Terms of Use, the Privacy Policy or any applicable law.
6. **Severability.** If any term or provision in this Agreement is found to be void, against public policy, or unenforceable by a court of competent jurisdiction and such finding or order becomes final with all appeals exhausted, then the offending provision shall be deemed modified to the extent necessary to make it valid and enforceable. If the offending provision cannot be so modified, then the same shall be deemed stricken from this Agreement in its entirety and the remainder of the provisions shall survive with the said offending provision eliminated.
7. **Headings.** Condition and section headings are for convenience of reference only and shall not affect the interpretation of the terms of this Agreement.
8. **Controlling Law and Venue.** It is understood and agreed that all the construction and interpretation of these Terms of Use and the relationship between the parties shall at all times and in all respects be governed by the



internal laws of the Commonwealth of Virginia, without giving effect to the conflict of laws provisions thereof. Venue of any action brought to enforce or relating to these Terms of Use or arising out of the relationship between the parties shall be brought exclusively in the courts located in Virginia.

9. **Limitations on Claims.** If you have a claim or potential claim against Education For Less under this Agreement, its Terms and Conditions, or its Privacy Policy, you agree to attempt to resolve the claim in good faith with Education For Less prior to instituting legal action. If you do institute legal action against Education For Less, you agree you must do so within one year of such claim arising. You also agree to resolve any claims on a case- by-case basis and expressly waive the right to participate in any class action against Education For Less relating to the App, the Services or the Scholarship Program.
10. **Force Majeure.** Education For Less shall not be deemed to be in default under this Agreement it delays performance, alters performance, or is unable to perform any obligation due to conditions beyond Approved College's reasonable control, including acts of God, pandemic, civil commotion, strikes, labor disputes, third-party attacks and governmental demands or requirements.
